Clubhouse Rules

1. Only Members of the Aqua Vista Home Owners Association (HOA) whose levies are paid in full are allowed to use the clubhouse facilities. Members may only book the clubhouse once per calendar month and the member must be present during the function. Under no circumstances are members allowed to book the clubhouse for non-members or for another member of the HOA.
2. The clubhouse is primarily a Day Function venue and must be utilised as such and vacated at the prescribed times.
3. The clubhouse is only available between 10AM and 7PM weekdays and Sunday's and 10AM till 11PM on Fridays and Saturdays. Any deviation from the times and rules regarding the clubhouse has to be approved by the directors in writing before the function date in question.
4. All bookings to be made at the office at least three days before the clubhouse are to be used. Bookings can only be made through Marlene (013 932 1815) at the office during office hours only. Only after receipt of the booking fee of R 850.00 will the booking be official. Use of spitbraai carries an additional R 350.00. Using the clubhouse without booking it, carries an automatic penalty of R 1000.00.
5. Visitors/Guests cars are only allowed to park at the waterfront if there is sufficient parking space available. Alternatively you will have to transport them to the waterfront and back. The facility can only accommodate a maximum of 50 people at a time.
6. No loud music and no alternative sound equipment are allowed and noise levels must be such that they do not disturb other members.
7. People using the braai and jetty facilities at the back of the water purification plant must use the pathway at the back of the clubhouse and are not entitled to use the toilet facilities at the Clubhouse. They must make use of the ablution facilities at the parking area.
8. You need to clean the Clubhouse before you leave.
9. Use facility at your own risk and you are liable for any and all damages while using the facilities. Abusing the Clubhouse facility will lead to disciplinary action against the relevant member who made the booking.
10. These Rules can be changed, by the board, without notice if so deemed necessary.
11. I accept that it is my responsibility to comply with all the relevant Covid-19 regulations that are applicable and that the HOA cannot be held liable for any failure on my part to act accordingly.

Special note of the following should be taken:

- A maximum of 50 persons allowed.
- Wearing of masks, where possible, mandatory.
- Social distancing and sanitising.
- Visitor's Function Register to be completed.

It will be the responsibility of the HOA to:

- Sanitise the Clubhouse before each function.
- Arrange for security to take temperature readings of each guest entering the Estate at the Security Gate.
